tion of an empty nest but will our little chickadee be insured!?

Dear Scrambled:

You never really can prepare your checkbook for the surprises that a college kid brings and of course you've watched National Lampoons Animal House so, of course you're feeling a little scrambled!

Don't be chicken, just call GBP! Below are a few things to consider:

First of all, remember that insurance

companies consider college students living in a **dormitory** to be residents of their parents' home, temporarily residing elsewhere. Insurance Companies also consider your son or daughter's dorm-room contents to be "personal property, located off premises". Most homeowners/renters policies limit coverage up to 10 percent of personal property, off premises. If you have \$75,000 of contents coverage at home, you will have \$7,500 for an off premises dorm room. You will need to decide if that's enough to repair or replace all electronics and other items likely to fill your trunk, back seat, and roof rack in the fall. If it's not, ask your GBP Account Manager about purchasing a separate renters policy or property policy for the dorm room.

If you are considering renting an **apartment off-campus** you should know that most insurance companies deem off campus apartments to be a permanent residence and therefore will not be covered under the parents' homeowners/renters policy for contents or liability. Generally, the person who signs the lease is held liable (and may be sued) if someone is injured on their leased premises or by their property. Re-

gardless of who signed the lease, when your child is living off-campus they should obtain their own renters policy.


Your little chickadee will really enjoy a care package or two as long as it's not school supplies (gift certificates for food, clothing and fuel)!!

Chardonnay has a buttery taste that goes well with poultry and seafood like lobster or scallops. Stay away from acids like tomato, not good with Chard's. So if you are grilling light mild foods with mild sauces, Chard's your grape.

Zinfandel is a classic BBQ wine. It will go with most meats and will not be overshadowed by the sauces or rubs that we use. It is a perfect compliment to steak or even a burger. Get out of the Cabernet and Merlot rut, Zin is a better BBQ wine.

Remember to serve the white wine at about 55 degrees and the red slightly chilled, not cold. By the way, just for fun on a very hot evening while sitting in the back yard, chill a **Sauvignon Blanc** and sip it. Hey, it's your back yard, nobody's looking and you will be surprised how well it goes with the desert heat.
